The last update was made on 9 June 2021.

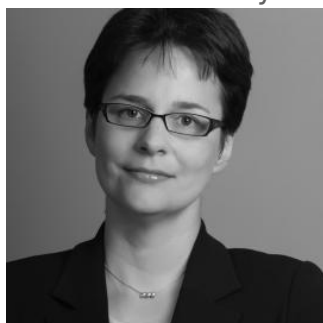

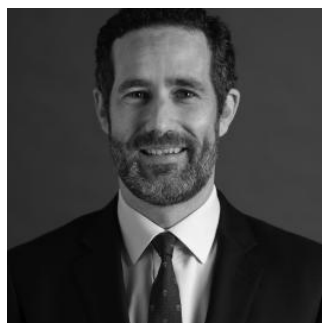
