Herbert Smith Freehills has been recognised in the 2017 Janders Dean and LexisNexis Legal Innovation Index for the third consecutive year. The awards were announced last night at a ceremony in Sydney.

In collaboration with Justice Connect and Neota Logic, Samantha helped to develop Australia's first web app that helps not-for-profit organisations to understand their income tax status.
