The Charter of LGBT Commitment sponsored by *l'Autre Cercle* offers a formal framework for policies to promote diversity and prevent discrimination. The Charter was designed by companies that wanted the subject to be included in their diversity policies.

*L'Autre Cercle* is an association created in 2012 to combat discrimination based on sexual orientation and gender identity. In the Charter, signatory companies or organisations make a commitment to:

- Creating an inclusive environment for LGBT people;
- Ensuring that everyone has equal rights and receives equal treatment irrespective of their sexual orientation and sexual or gender identity;
- Supporting those who have been victims of discriminatory statements or actions;
- Measuring progress and sharing good practices to encourage changes in the overall professional environment.
