Paula, who is Head of the firm's Global Arbitration practice, has been Vice President of the Court for several years and also a LCIA Board member for a decade.

Her advocacy skills were formally recognised in 2014 when she was awarded the title of QC.

Paula plays an active role in the international arbitration community and has links with a number of institutions and arbitral organisations around the world. She has served as an officer of the IBA Arbitration Committee and is included on the arbitrator panels of many of the leading institutions as well as the Energy Arbitrators List.

She will take over this role from outgoing President Judith Gill QC in May 2019 and will continue in practice at Herbert Smith Freehills whilst undertaking her new LCIA responsibilities.
