## EXPERIENCE

Beverly has represented individuals, companies and sovereign states in cases in both English and Spanish, spanning a broad range of industry sectors, under the rules of institutions including the ICC, ICSID, LCIA, HKIAC, SIAC, SCC and UNCITRAL. Beverly has also acted as administrative secretary in international commercial arbitrations.

Beverly has been involved in several International Bar Association (IBA) initiatives, including acting as Secretary to the Chair of the IBA Conflicts of Interest Subcommittee, in the process of the evaluation and revision of the 2004 IBA Guidelines on Conflicts of Interest in International Arbitration. Beverly was also a member of the editing team of the IBA Arbitration Committee International Arbitration Country Guides and has acted as assistant to the editor of the IBA Litigation Guide and IBA Litigation Newsletter.

Prior to joining the firm, Beverly worked in the arbitration team of a leading Spanish law firm. Beverly's experience includes:

- Representing The Kingdom of Spain in two investment arbitrations under the SCC and UNCITRAL Rules respectively, filed by multiple claimants who invested in the Spanish photovoltaic industry under the Energy Charter Treaty
