Stephen has over 20 years' experience and has been involved in a significant number of landmark competition and regulatory cases at EU and UK level. He specialises in all aspects of EU and UK competition law, including merger control, cartels and abuse of dominance cases, market investigations, competition disputes and strategic advice. As a competition litigator, Stephen has conducted complex competition disputes (both regulatory appeals and private enforcement).
