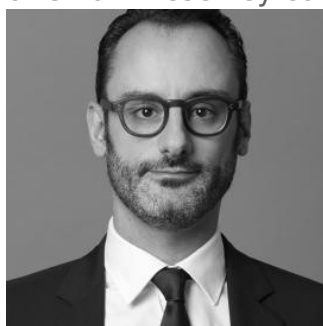
Through its investment, Eurazeo will aim to address the challenge of incorporating sustainability considerations into the construction and operation of data centers. Eurazeo intends to support Etix in achieving its environmental objectives, notably by securing carbon-free energy supplies. Eurazeo's investment will also be used to support the company's development whether organically or through bolt-on acquisitions.

This investment is the fourth made by Eurazeo's infrastructure team and the first in the digital space. It is in-line with its mandate to invest in the energy and digital transition and contribute to a low-carbon and sustainable economy.

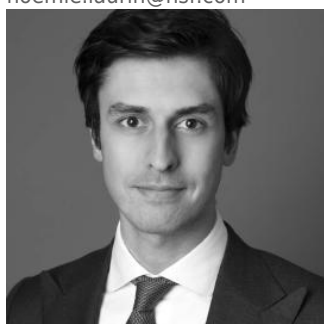

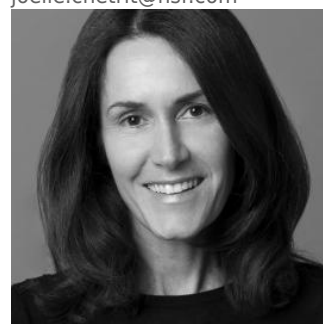
